## Contest Rules and Regulations

The winner is expected to represent St. Francois County at St. Francois County Fair Events and make at least 3 public appearances throughout the year.

Contestants must be citizens of the United States and St. Francois County, belong to a Farmington FFA/St. Francois County 4-H club and be in good standing, or attend a school in St. Francois County.

Contestants must be single, not married, and not residing with a male. The Queen will automatically relinquish her title if she enters into a marriage contract or if she chooses to cohabitate with a male.

Contestants must be no less than 16 years of age or older than 21 years of age as of July 1 of the year she participates.

Contestants will be judged on Personal Interviews (30%), Public Speaking or Talent (40%), Evening Gown (15%), and Stage Interview (15%). The judge's decision will be final. If for any reason the winner is disqualified, the First Runner Up will be declared the winner. If there is a tie, the Interview Scores (combined) will be the tie breaker.
